WHO IS CEPIA?

CEPIA

CEPIA is a non-profit, non-governmental organization founded in 1990, which has been working for women's rights in Brazil for 33 years.

It promotes the strengthening of human rights and the exercise of citizenship, especially among the most excluded groups, such as women in all their diversity, adolescents and young people in situations of vulnerability. All its projects are developed with a focus on the intersectionality of gender, race and ethnicity and social class, in order to include the diversity of women and youth and their different experiences, needs, vulnerabilities and potential.

Since its foundation, **CEPIA** has developed partnerships with government bodies, academic institutions, organizations and social movements to strengthen and expand its work, which is carried out through two main lines of action that complement each other: **Human Rights, Health and Sexual and Reproductive Rights** and **Human Rights, Violence against Women and Access to Justice**. Both programs invest in the empowerment and training of women, adolescents and youth in human rights.

The programmes also include the training of managers, health workers and justice workers to advocate for public policies, continuing training for leaders of organizations and social movements, youth collectives, students, as well as professionals who play a role in the formulation and development of public policies.

The aim of the programs is to share knowledge and skills for the promotion and defense of human, social, sexual and reproductive rights and gender equality.

MISSION

Strengthening democracy, promoting the implementation of human rights, social justice, gender, race and ethnic equality and the strengthening of citizenship, especially for women and those who have historically been excluded from the full exercise of their rights.

VISION

A democratic society, with social justice, solidarity, without discrimination based on gender, race/ethnicity and other forms of exclusion.

CEPIA also produces and compiles a collection of publications, manuals and audiovisual content that support educational activities and produces and disseminates knowledge on these topics, helping to inform education and health professionals in their dialogue with youth and adolescents. These materials are also used in peer training workshops and seminars.

CEPIA has a multidisciplinary team and its communications sector invests in digital technologies, as well as the social media @partiu.papo.reto, to raise awareness among youth using tools that are widely used by them.

CEPIA has extensive online production, working with a horizontal approach that promotes a democratic and participatory institutional environment, involving young people in the development of programs.

As part of its programs, CEPIA carries out research, training activities and advocacy actions, involving representatives of organizations from other countries, including Latin America and Lusophone Africa, among others.

The organization invests in the production of audio visual materials, investment in the social media



HUMAN RIGHTS, ACCESS TO JUSTICE AND VIOLENCE AGAINST WOMEN

Violence against women is a complex, multidimensional and universal phenomenon. Race and ethnicity, social class, sexual identity and other conditions increase the degree of vulnerability of women in situations of violence. This program includes training professionals in the areas of security, justice, social assistance, health and education, public policy managers, women's organizations and movements; advocacy actions for laws and public policies and access to justice; monitoring the effectiveness of the Maria da Penha Law and the Feminicide Law; conducting research; producing and disseminating knowledge and information on social networks and in the mainstream press. It also includes participation in national and international commissions and forums focused on the struggle against gender violence.

With this program, **CEPIA** has established partnerships and links with feminist movements and organizations, justice and security institutions, universities and networks that care for women in situations of violence. **CEPIA** has also established partnerships and links with national and international feminist organizations and consortiums, with the Rio de Janeiro State School of Magistrates (EMERJ), as part of the Women's Security Commission (CEDIM), the EMERJ Domestic and Gender Violence Forum and the Women's Learning Partnership (WLP). **CEPIA** is part of the Maria da Penha Law Consortium for the end of violence against women, which has monitored legislative proposals, continued extensive research work and partnerships with social movements to draw up a legislative proposal for a general law on gender-based violence against women, and maintained dialogue with parliamentarians and the Ministry of Women's Affairs.

HUMAN RIGHTS, SEXUAL AND REPRODUCTIVE HEALTH AND RIGHTS

The right to sexual and reproductive autonomy implies freely deciding whether or not to have children, when and how many. It also implies living one's sexuality without violence or coercion. This program works on different fronts: advocacy actions with society and the state, including *amicus curiae* before the Supreme Court; training and awareness-raising for different audiences, such as communicators, university students,, health professionals, adolescents and adult women; campaigns on sexual and reproductive rights. It also works for the social decriminalization of the right to abortion and for health services for victims of sexual violence.

With these programs, **CEPIA** has established partnerships and links with UN Women, the United Nations Population Fund (UNFPA) and the Fòs Feminist Alliance, as well as with the academy, medical associations and national and international networks. CEPIA is also a member of Rio de Janeiro's Maternal Mortality Committee and collaborates with the Health Department's RAP da Saúde, which focuses on the health of adolescents and youth.

INSTITUTIONAL POLICY FOR THE PROTECTION OF CHILDREN, ADOLESCENTS AND YOUTH

Since 1990, **CEPIA** has been dedicated to strengthening the observance of human rights and has an Institutional Policy for the Protection of Children, Adolescents and Youth. The aim of this policy is to provide a set of guiding principles and standards for the creation of a safe environment for children, adolescents and youth, being an ongoing process to safeguard the integrity, well-being and safety of children, adolescents and youth, as well as to promote a safe and secure environment for children,



adolescents and youth, as well as to promote positive attitudes towards these age groups. **CEPIA** believes that the implementation of an Institutional Policy for the Protection of Children, Adolescents and Youth is a priority to support its actions and institutional conduct.

In line with this commitment, CEPIA is part of the Collegiate Coordination of FEPETI/RJ, the State Forum for the Prevention and Eradication of Child Labor and the Protection of Adolescent Workers.

BRAZILIAN CONTEXT

The year 2023 began with the investiture of President Luís Inácio Lula da Silva and was characterized by a political space that was more favorable to human rights, including the creation of new ministries such as the Ministry of Racial Equality and Indigenous Peoples, with people committed to the human rights agenda at the head of these ministries. Despite the attempted *coup d'état*, democracy won and the crimes committed and their perpetrators are being investigated, prosecuted and punished.

In the field of sexual and reproductive rights, the government has positioned itself to withdraw from the Geneva Consensus group, made up of ultraconservative countries opposed to this agenda.

Despite the victory of democracy and Brazil's withdrawal from the Geneva Consensus with the election of President Lula, the bench of religious fundamentalists and ultraconservatives remains active and has even expanded with the 2022 elections, going against gender agendas, against LGBTQIA+ rights, being anti-sexual and reproductive rights and bringing the agenda of the ("traditional") family, morals and customs as its flagship.

In this context, the women's movements have remained active, fierce and constant in their defense of their rights, in order to stop anti-rights proposals, through links between NGOs and feminist networks.

CEPIA has maintained a strong presence in ongoing dialogue with executive bodies, such as the Ministry of Women's Affairs and the Ministry of Health, to strengthen and expand services that perform voluntary termination of pregnancy in the cases provided for by law. In conjunction with REBRAPD, CEPIA also worked with the Secretariat of the Presidency of the Republic and the Ministry of Foreign Affairs to reactivate the National Commission on Population and Development (CNPD). In relation to the Judiciary, CEPIA has promoted advocacy actions aimed at influencing the Supreme Court to approve the **Argument of Non-Compliance with a Fundamental Precept - ADPF 442** on the decriminalization of abortion, having invested as *amicus curiae* in this action. Justice Rosa Weber put ADPF 442 on trial and voted in favor of it, voting to decriminalize the voluntary interruption of pregnancy (abortion) in the first 12 weeks of gestation. However, the judgment was suspended at the request of Supreme Minister Luís Roberto Barroso, and will therefore continue in a plenary session on a date to be decided.

National data reveals an alarming number of women with low access to rights and social protection; women who are single mothers responsible for their families, women who are unemployed or in precarious jobs without social protection, women victimized by domestic violence, many of whom are totally economically dependent on their aggressors; women without access to credit and housing. The process of escalating gender violence against women has been observed, especially against black women, as evidenced by national surveys that point to an increase in physical and sexual aggression, femicides, sexual harassment, cybercrime and forms of institutional violence practiced by state agents.

The fragility of services for women in situations of violence has also been pointed out by women's movements, as has the need for preventive actions aimed at changing mentalities. In this direction, the Ministry of Women launched the Campaign against misogyny, reopened Line 180 and resumed dialog with women's movements, including dialog with the Maria da Penha Law Consortium, of which CEPIA is a member.

Throughout 2023, CEPIA expanded its efforts to strengthen its programs and actions in defense of democracy and human rights, especially women's human rights on different fronts: advocacy with the state and civil society, maintenance of actions to resist setbacks, struggle to advance the human rights agenda; continuity of training, capacity building and qualification actions in human rights for broad sectors with a gender and ethnic-racial perspective; maintenance and expansion of its articulation with national and international women's movements and organizations; various initiatives with women and youth from popular sectors; maintaining and expanding dialogues with the mainstream media and social media; working with the Brazilian Supreme Court, strengthening its communications department, which has proved to be a strategic tool in investing in and strengthening its institutional capacities.



VOTE TO DECRIMINALIZE ABORTION

The Argument of Non-Compliance with a Fundamental Precept (ADPF) 442, which discusses the decriminalization of abortion, has been scheduled by Rosa Weber, president of the Federal Supreme Court (STF), to take place in September 2023. CEPIA has started a series of posts about the vote and the importance of decriminalizing abortion.




